### THE ANNE AND STEPHEN STEIGRAD SCHOLARSHIP 2021

Thanks to the significant generosity of Anne Steigrad (EPSTEIN, 1959) and her husband Stephen, a scholarship is offered for a girl who would be starting secondary school in Year 7, 2021 and whose mother or grandmother attended SCEGGS Darlinghurst.

This half scholarship is means-tested and aims to provide the opportunity for a student to attend SCEGGS whose family would not otherwise be able to afford to send them to the school without this assistance. Families are asked to complete a Statement of Financial Position, which is attached, and return this with the other materials.

The scholarship will be awarded on the basis of application and interview. It is envisaged the scholarship will cover the student's entire schooling provided that the scholarship winner continues to contribute positively to the School.

An application form is attached together with details of other information to be submitted by **Friday 16 October, 2020**. The Anne and Stephen Steigrad Scholar will be expected to make a significant contribution to the School in one or more areas. The Selection Committee will take into account:

- Educational background and performance
- Recent co-curricular involvement
- Personal qualities and character
- Commitment to the life of SCEGGS
- Family and financial circumstances

The normal enrolment procedure including registration and enrolment fees will apply in respect of a scholarship winner who is new to the School.
